Started negotiations in 2014 -2016 for implementing a Solar Panel System on Port property. Discussed Problems with the energy infrastructure in the United States. Will cost approximately 40 Billion dollars to upgrade infrastructure in NY alone, The Governor is looking for new ways to manage the rising cost of energy and the use of fossil fuels, as there is no end. These older systems are less reliable. The Governor has requested that Governmental buildings become 30% Green, changing over to Micro – grids and Localized generation of their own power to some extent. Discussed PPA which is an LLC and also the use of investors and Banks, it pays for all maintenance which you can use local companies and people, it covers ins. No Capitol is required – all equipment is paid for by energy payment you pay for use of the equipment and you also continue paying National Grid. Phase 2 - evaluate how much energy you have used in 12 months and make a determination for additional CHP, battery storage, and additional onsite areas for Solar panels. Also, to reduce the cost of energy on demand form National Grid when you know you will have a large increase in the need for electricity (ship coming in) turn one item on every 15 min to half hour so the large demand is over a period of time not all at once this will help reduce the cost from the electric company.
