

Malone Trucking & Excavating, Inc. in accordance with the conditions of award stipulated in their bid; and contingent upon New York State Department of Transportation concurrence which was competitively bid in accordance with Port of Oswego Authority and New York State requirement. The motion was seconded by Mr. Enwright. Motion Passed 5-0.
