ADMINISTRATIVE REPORT – Executive Director & Administrative Services Manager

You may have seen many contactors on site who are working on the rail and the rock projects. The rock project is finishing up and we are negotiating a paving schedule for the repairs to the north end where it was taking place. We are looking to recapture that space for use. There is also a six foot of rail in that area that will need to be fixed. Rail work on the intermodal area, where we applied for a grant, will also be worked on. In the end, all the rail should be more or less touched. We were successful in getting a Hazardous Abatement Port Grant for \$46,000.00. Next month we will be starting a new Port Security Program where we will be taking a photo of each person entering the port. It will record each person's time in, where they have been and the time they leave. This new program is in cooperation with Border Patrol. We will also be able to automate our scales and invoice process using this new program and should have it in place by the beginning of next year. We just bid on an army surplus 25 ton crane for use at one of our facilities. As far as project management, we are working with \$200,000.00 for improving the USCG Station. We are building a pole barn and making some building improvements. The work should be completed in December and will be partially reimbursed thru their lease. In October had a barge that had a record discharge rate of ~700 pieces an hour. We also had a last minute barge diverted to us and we will always make room for cargo. Perdue became a big investor in the port and our other ventures. They have paid for over half of the new grain conveyor that will also be able to load ships. We are also going after a records management grant to help computerize our records. There is a lot of activity going on with development of inland ports, not only in New York State but in other areas of the country. The Lieutenant Governor recently visited the port and was impressed with all the activities going on at the port; in particular the work we do with the SUNY Oswego & Citi (BOCES) student interns. The Lieutenant Governor is also excited that we are working towards a USDA Certification. We are currently in discussions and negotiations for the selling of the former Price Chopper and the former Hammermill properties. The port is also one of the sponsors for the upcoming Oswego Community Night Syracuse Crunch Hockey game.

CHAIRMAN

The Chairman presented the results of the Board of Directors Annual Self Evaluation Survey that is required by the Authorities Budget Office (ABO). The evaluations were anonymous and once received back were reviewed by the Governance Committee. Seven of the eight evaluations were received back the responses consolidated with most responses being favorable. The committee has made notes on items that will be used to make improvements on. The chairman will be sending out the results to the Authorities Budget Office tomorrow.
