And then to further delegate authority to the Executive Director so that the port, its contractors and designees may take those steps that are necessary to secure that portion of the structure that has already been erected so as to preserve the same, to the extent possible, from damage due to the weather and elements, fire or other loss. The motion was seconded by Mrs. Cosemento. Motion Passed 5-0.

**Motion 10-05-2106** – Mr. Schneider made a motion that the third condition of the State New York Supreme Court of the County of Oswego decision to stay the further erection of Dome 4 remains in full force because the Port as the lead agency, through its Board, needs to conduct a full and complete SEQRA review of the further construction and erection of Dome 4, referred to herein as the grain storage structure, as a Type I action starting with a full EAF and ending with a reasoned elaboration and determination by the Board in writing. Mr. Schneider proposed that the Board provides delegation to the Executive Director to commence that process in accordance

with paragraph 4, on page 10, of the decision by Judge Gilbert. And further state that for clarification purposes that the term square grain storage structure, as is further referred to in the following paragraph, making sure that the Dome 4 is reconfigured as the structure is referred to as the square grain storage structure that it is our interpretation and belief that language is being used euphemistically to refer to the storage building, but that does not mean that the building would be used for storage of grain solely as the building was being built for primarily potash and salt. The motion was seconded by Mr. Kares Smith. Motion Passed 5-0.

#### Contract No. 3: Dome 4

Eagle Associates of Cazenovia, LLC was not onsite this week. The Contractor has to secure the Pre-cast concrete Bin walls, caulk precast panels, install fabric roof covers on Dome trusses, overhead door, and retractable hatch, and asphalt floor and perimeter finish. These remaining work items are on hold until notice is given to proceed. Port personnel moved Brightspan fabric roofing and access hatch equipment to inside storage in Transit Building for the winter.

### Contract No. 4: Silo, Grain Equipment & Controls

W. D. Malone had no personnel on site this past week. Sub-Contractors, Milton Paving, and J&A Mechanical were on site this week. Milton Paving completed asphalt placement by paver and by hand. They raked, compacted with a plate compactor, as well as a Double Drum Roller on the East side, around the Receiving Pit and adjacent railroad tracks. J&A Mechanical continued compressed air system installation having finally receiving working drawings from A. N. Martin Sub-Contractor Ventilation Control Products on Wednesday. They ordered materials for additional line to top of bag house, and ordered items needed to continued installation of Air system in the Control Building. Next week W. D. Malone will be on site with Sub-Contractors and Representatives to commence commissioning of the Grain Handling System.

#### Contract No. 5: Grain Control/Electrical Building Construction & Electrical Infrastructure

Rombough Electric had a crew on site all week working 8 hour days, while W. D. Malone's Sub-Contractor J&A Mechanical continued work on the compressed air and mechanical systems. Rombough Electric energized the Electric Gear in the Control Building Electric Room on Friday morning. They continued to install conductors to panels, switches, and Control Panel. On Friday, a Representative from Northeast Controls was on site to begin installation of Control Program in the hardware of the new Control Panel in the Electrical Room. Next week Rombough will be completing work on Control Wiring and final Electrical connections, as well as continued lock out/tag out program in conjunction with commissioning of the new Grain Handling System Mechanicals and Controls. J&A Mechanical will be continuing installation of the compressed air and mechanical systems in the Control Building.

#### Contract No. 6: Warehouse Laboratory Renovations

Bellows Construction Specialties, LLC had a Foreman and Sub-Contractor on site this week. Bellows Foreman coordinated their Sub-Contractor Grayco's activities on site. Grayco installed insulation board and batts, gypsum drywall board, and finishing compound on the new walls in the Probe Room. Rombough Electric installed conduit, panels, and step down transformer for Probe Room. No work was performed this week in the USDA Room. Next week Bellows Construction Specialties, LLC and their Sub-Contractors will continue work in the Probe Room priming and painting while coordinating with Rombough Electric and J&A Mechanical. Rombough Electric and J&A Mechanical will continue electric and HVAC in both the Probe and USDA rooms.

#### Contract No. 3: Dome 4

Eagle Associates of Cazenovia, LLC was not onsite this week. The Contractor has to secure the Pre-cast concrete Bin walls, caulk precast panels, install fabric roof covers on Dome trusses, overhead door, and retractable hatch, and asphalt floor and perimeter finish. These remaining work items are on hold until notice is given to proceed.

### Contract No. 4: Silo, Grain Equipment & Controls

W. D. Malone had no personnel on site this past week. A Superintendent oversaw Sub-Contractors as they commenced commissioning of the new Grain Handling System and placement of Silo #1 into service for the Port of Oswego. J&A Mechanical Pipe Fitters were on site all week and they completed the piping for the compressed air system for operation of the dust collection system. A. N. Martin's crews were here, as well as Sub-Contractors Ventilation Control Products and Inter Systems. By Tuesday evening A. N. Martin had the Handling System running and they placed soybeans in the Silo. Work continued all week on the compressed air system and programming the control panel for automated control of the entire system. Next week W. D. Malone's Sub-Contractors and Representatives from the Port will continue to placing the Silo and Grain Handling System in service.

### Contract No. 5: Grain Control/Electrical Building Construction & Electrical Infrastructure

Rombough Electric had personnel on site all week. J&A Mechanical continued work on the compressed air and mechanical systems in the new Control Building. Rombough Electric energized individual Switch Gear and additional Controls wiring in conjunction with a Representative from Northeast Controls who installed the Control Program in new Control Panel in the Electrical Room. Next week Rombough will be completing work on Control Wiring and final Electrical connections on the Compressed Air System, Northeast Controls will continue with commissioning of the new Grain Handling System Controls. J&A Mechanical will be continuing installation of the HVAC systems in the Control Building.

#### Contract No. 6: Warehouse Laboratory Renovations

Bellows Construction Specialties, LLC had a Foreman and Sub-Contractor(s) on site this week. Bellows Foreman coordinated their Sub-Contractor Grayco's activities as they completed the finishing of joint compound on the new walls in the Probe Room. Commercial Painting primed and painted all walls in the new Probe and Storage Rooms. Rombough Electric is installed conduit, branch circuits, devices and feeds to panels from the step down transformer. They also installed lights and devices in USDA Room #109 and the adjacent corridor. J&A Mechanical began working on the HVAC Systems in new Probe Room. Next week Bellows Construction Specialties, LLC will be largely on hold and waiting for materials and J&A Mechanical and Rombough Electric to complete their work.

Ken Rupert (NYSDOT) was on site during the first part of the week to observe the commissioning of new systems.

The Contractor has to secure the Pre-cast concrete Bin walls, caulk precast panels, install fabric roof covers on Dome trusses, overhead door, and retractable hatch, and asphalt floor and perimeter finish. These remaining work items are on hold until notice is given to proceed.

### Contract No. 4: Silo, Grain Equipment & Controls

W. D. Malone had a Superintendent on site Tuesday for the Weekly Progress Meeting and a Foreman on site Monday installing cores in the door hardware of the Control Building. Sub-Contractors J&A Mechanical, Northeast Controls, and A. N. Martin were all on site throughout the week. J&A Mechanical Pipe Fitters completed the piping for the compressed air system. A. N. Martin coordinated programing with Northeast Controls, and trouble shot a shutdown issue encountered Tuesday afternoon. Northeast Controls worked on programming automated control of the entire system, and they instructed Port Personnel on operating the Grain Handling System as Port labor put truckloads and stored soybeans directly into the new Silo.

#### Contract No. 5: Grain Control/Electrical Building Construction & Electrical Infrastructure

Rombough Electric had personnel on site all week. W. D. Malone's Sub-Contractor J&A Mechanical completed the compressed air system in the new Control Building. Tin Knockers installed ductwork for HVAC system. Rombough Electric worked in conjunction with a Representative from Northeast Controls on the Control Program, and Rombough began installing panels, conduit, and wiring to the Electrical Vault for the Barrel Building. Next week Rombough will be completing work on Control Wiring, Electrical connections on the Compressed Air System Equipment, and wiring the Barrel Building Electrical Vault. Northeast Controls will continue loading new Grain Handling System Controls. J&A Mechanical will be continuing installation of the HVAC systems in the Control Building.

Eagle Associates of Cazenovia, LLC was not onsite this week. The Contractor has to secure the Pre-cast concrete Bin walls, caulk precast panels, install fabric roof covers on Dome trusses, overhead door, and retractable hatch, and asphalt floor and perimeter finish. These remaining work items are on hold until notice is given to proceed.

### Contract No. 4: Silo, Grain Equipment & Controls

W. D. Malone had a Superintendent on site Tuesday for the Weekly Progress Meeting and a Foreman on site Tuesday and Wednesday installing and adjusting door locksets and hardware on the Control Building. Sub-Contractor J&A Mechanical and Northeast Controls were on site a portion of this week. J&A Mechanical installed makeup air louvre in Compressor Room. Northeast Controls Technician was on site for Tuesday's Weekly Meeting and met with Representative from A. N. Martin regarding the scheduled Safe-Grain system startup in December. Port Personnel operated Grain Handling System to offload truck and stored soybeans directly into the new Silo. No work is scheduled on site next week for W. D. Malone or their Sub-Contractors. The Port may move their large Masaba conveyor into place for A. N. Martin to finish grain spout to the conveyor.

# Contract No. 5: Grain Control/Electrical Building Construction & Electrical Infrastructure

Rombough Electric had personnel on site all week, and they are wiring the Control and Compressor Rooms, as well as assisting Electrician working on Contract No. 6. W. D. Malone's Sub-Contractor J&A Mechanical completed the ductwork for the Compressor and HVAC system. Next week Rombough will be completing work on Control Wiring, assisting with startup of the Compressed Air System Equipment. Northeast Controls will continue preparations on the Control Program for Safe-grain system startup and remote tape reader for the USDA Laboratory Room. J&A Mechanical will be installing temperature controls on the HVAC systems in the Control Building.

They have not had any other crews however, Sub-Contractors J&A Mechanical and Northeast Controls were on site to complete mechanical and Grain Handling System control work. A. N. Martin and Northeast Controls have scheduled Safe-Grain System startup for December 12th. Port Personnel continue to operate Grain Handling System to offload truck and move stored soybeans directly into the new Silo. W. D. Malone will be installing door hardware next week and their Sub-Contractors will be preparing for additional grain handling system startup and compressed air system. The Port moved their large Masaba conveyor into place for A. N. Martin to finish the grain discharge spouting from the silo to the conveyor.

#### Contract No. 5: Grain Control/Electrical Building Construction & Electrical Infrastructure

Rombough Electric had an Electricians on site all week wiring electrical panels in the Barrel Building, as well as working on Contract No. 6. J&A Mechanical completed insulating on the Control Building HVAC system ductwork. Startup of the Compressed Air System Equipment is scheduled for next week by J&A Mechanical. Northeast Controls will be working on the telemetry issues on the Safe-grain System, and will assist Rombough Electric with startup. J&A Mechanical will be installing temperature controls on the HVAC systems in the Control Building.

#### Contract No. 6: Warehouse Laboratory Renovations

Bellows Construction Specialties, LLC had a foreman on site one day this week. They are waiting on installing ceiling metal framing and acoustical grid once the installation of the HVAC units is done. J&A Mechanical completed the truck probe sampler, and Rombough Electric installed and terminated electric to it. J&A Mechanical also installed the HVAC units above the Laboratory Ceiling and the A/C Unit inside and outside the Laboratory Room. Next week Bellows Construction Specialties, LLC will be installing framing and ceiling grid system in the Laboratory Room. J&A Mechanical will be continuing HVAC unit install, while Rombough Electric will run power to the new HVAC Systems.

#### <u>General</u>

This week's weather was seasonably early December weather with a rain/snow mix of precipitation later in the week.
